3. Whether the concerned organization is submitting Annual Audit Report on a regular basis, if so the report for the last three years.
4. Whether the proposed scheme will be utilized entirely for social benefit (no commercial exploitation).
5. Detailed performance report of the organization stating their activities regarding social development.
6. Agreement (as per MPLADS Guideline Annexure-V).

If the admissibility report is positive, vetted plan & estimate in respect of the scheme should be submitted along with the admissibility report at the earliest for enabling us to accord administrative approval and release of fund thereof.

Further you are also requested to submit bank details like Account holder name, Bank name & branch, Account number, IFS Code for transfer the fund to the accountant along with photo copy of your passbook bank details page for ready reference.

N.B. : In case of Highmast Lamp installation/LED lamp installation or any other electrical works concerned executing agency has to submit a declaration that it would bear the post installation maintenance and electrical consume charges in this regards.

In this connection, it is mentioned that no contingency/centage charge will be allowed for the scheme(s).

This should be treated as Extremely Urgent.


