খেলাধুলা পরিচালনা ও সাধ্যমত রক্ষনাবেক্ষন করে আসছি । মাঠটি ১৯৯২ সালে তদানিন্তন
সাংসদ তহবিলের অর্থে পাঁচিল দিয়ে ঘেরা । এই মাঠ এই বিশাল এলাকার মানুষের নয়নের মনি ।
সারা বছর ফুটবল , ক্রিকেট সহ বিভিন্ন টুর্নামেন্ট , এলাকার সমস্ত স্কুল ও সামাজিক
সংগঠনগুলির বার্ষিক ক্রীড়া প্রতিযোগীতা ইত্যাদি , বিভিন্নভাবে এই মাঠ বছরের মধ্যে ৯/১০ মাস
দারুন ব্যস্ত থাকে । বাকি ২/৩ মাস মাঠের বড় অংশে জল জমে থাকে - খেলাধুলা বন্ধ থাকে ,
মশা জন্মায় ।

আমরা নিতান্ত অসহায় , অপারগ হয়ে আপনার দ্বারস্থ হয়েছি । এই মাঠের দলিল আমাদের নেই
কিন্তু ১৯৫৭ সাল থেকে সরকারী রেজিষ্ট্রিকৃত সংগঠনের এই মাঠ এলাকার একমাত্র খেলার মাঠ
হিসেবেই প্রতিষ্ঠিত (এ প্রশ্নে স্থানীয় তৃনমূল কাউন্সিলারের লেখা স্বসাপত্ত যুক্ত হল) । এটাও
সত্য যে অতীতে শেষ ২০১০ সাল পর্যন্ত , ২/৩ বার স্থানীয় এম পি বা এম এল এ অনুমোদিত
সামান্য টাকায় মাঠের একাংশের কিছুটা উন্নয়ন হয়েছিল । এবারেও আমরা মাননীয় সাংসদ শ্রী
সৌগত রায় মহাশয়ের কাছে আবেদন করেছি , যার সদর্থক উত্তর এখনো পাইনি । এই মাঠ প্রসঙ্গে
সমস্ত তথ্য জেলা প্রশাসনের কাছে দেওয়া আছে , তাই অতীতে জেলা শাসকের মাধ্যমেই
প্রতিক্ষেত্রে এই মাঠের উন্নয়নে অর্থ অনুমোদিত হয়েছে । আপনি যদি দয়া করে এই প্রসঙ্গে একটু
দৃষ্টি দেন তবে বিরাটিতে ১৯নং ওয়ার্ডে কেবলমাত্র এই বড় মাঠই একটি সুন্দর স্পোর্টস
কমপ্লেক্স গড়ে তোলা সম্ভব । সেক্ষেত্রে এলাকার চেহারাই বদলে যাবে , যার সুফল পাবে এই
বিশাল এলাকার বিরাটীর অসংখ্য ক্রীড়াপ্রেমী মানুষ ।

আশা করি আপনার আন্তরিক সহযোগীতা থেকে আমরা বঞ্চিত হব না , তাই আপনার
উত্তরের অপেক্ষায় রইলাম ।
